In This Season of Thanks, Thank You for Three Valley By Donna McCollum

Did you know 2024 is Three Valley Conservation Trust's thirtieth anniversary? We hope you do! We have spent the year exploring our roots with articles "Celebrating 30 Years" and "Founders" in the 2024 spring newsletter, enjoying several Lunar Feasts, and celebrating at the lovely Farmer's Feast dinner and anniversary event in September. We have celebrated the advances 3VCT has made from being a completely volunteer organization with a handful of easements to having a professional staff handling 220+ easements that protect over 25,000 acres. We thought in this time of thanksgiving we could get an idea of what 3VCT easement-property owners and partners think. Here's how a few answered the question, "What has Three Valley meant for you?" Joe Dumyahn, Senior Natural Resources Manager, MetroParks of Butler County

Thanks for giving MetroParks the opportunity to give our perspective of what 3VCT means to us. First, MetroParks considers Three Valley Conservation Trust a strategic partner in the conservation of natural habitats in SW Ohio. Angst Nature Preserve is a prime example of this relationship. Through our combined efforts we were able to add 84 acres of protected land to the MetroPark system, deterring development, creating wildlife habitat, and providing additional green-space for recreation. Salamander Run MetroPark is another example. Three Valley Conservation Trust and their contractors converted a 126-acre, rundown farm with overgrown pasture and degraded agriculture fields to a diverse native habitat. This high value natural area is now maintained by the MetroParks and open to the public. There are conservation easements on both of these properties and others, including Mill Race Preserve MetroPark and Timberman Ridge MetroPark. Through this important relationship there are likely to be more easements and MetroParks in the future.

Donna McCollum and Hays Cummins, conservation easement on 33 acres of forest, wetlands and prairies: Hays had a vision of what we could do with our acreage near Reily. We could work with US Fish and Wildlife (USFWS) to turn our marginally-arable acres into a prairie and wetland complex, then use those and the forest as an educational lab for ecological restoration, prairie establishment, wetlands, and stream protection. However, USFWS programs generally protect large properties, not small acreage like ours (11 acres then). It was our conservation easement that convinced them this small piece of land was worth some funding. Without permanent protection, USFWS would not have helped us create this complex of habitats that allowed Hays' vision to become a reality. Since 2007 thousands of people have come here for experiences in nature, hard work, and good times, usually followed by good food! For us, as educators and advocates for the natural world, it has been a dream come true. Thank you, Three Valley!

Jullie Primack, conservation easement on horse farm:

Old Stone Riding Center, a beautiful 70-acre farm, was passed to me in 2000 from my parents, who had owned and run it for 20+ years. Land ownership is a legal construct I have been happy to buy into, but as we cannot take money or possessions with us when we leave this earth, 3VCT's easement provides me the comfort of knowing stewardship of the farm will continue in future generations. I did not understand the complexities of what 3VCT does until I joined the Board in 2020. Although I still have much to learn, I have a great deal of respect for the founders, staff and Board members. In addition to peace of mind about the future, 3VCT has helped me find friendships with people who have sharp minds and similar interests. Thanks 3VCT!

Jeff Davis, ODNR Approved Herpetologist

As an undergraduate student at Miami University, I conducted an amphibian survey of Butler County. When I knocked on people's doors to ask if I could wade in their streams or hike through their woods to search for frogs, toads, and salamanders, it seemed I was turned away by more landowners in Morgan and Ross Townships than in other parts of the county. At the time I had no idea my livelihood 35 years later would center around amphibians. When Three Valley contracted with me to conduct surveys on properties it protected as part of the Paddys Run Conservation Project, I was introduced to many great conservation-minded landowners in those two townships where I was so often turned away as a college student. It might have been 35 or 40 years later, but thanks to Three Valley, I was given access to some wonderful properties and documented very diverse amphibian communities on them. Five of those properties are inhabited by the state endangered Cave Salamander. Thanks Three Valley, for protecting the habitats of my favorite creatures!

2024 EasementsBy Caitlin Brown, Land Protection Specialist

Three Valley's first easement to close in 2024 was an Ohio Department of Agriculture (ODA)-funded agricultural easement on Fred Voge's 82.589-acre farm in Twin Township, Preble County, Ohio. The Voge family protects over 1,100 acres of agricultural land in Preble County, with 21 3VCT easements within a 2-mile radius of the newest one. Fred's 83-acre farm is also Three Valley's first regenerative agriculture case study site, which is supported by soil health grants from American Farmland Trust and Land Trust Alliance. We hope that Fred's tremendous results from incorporating regenerative agricultural practices on cropland with past conventional management will provide inspiration to local farmers to integrate regenerative farming into their own practices.

Additional Land Protection Updates By Sarah Dumyahn, Chair, Land Protection Committee

The U.S. Department of Agriculture's Natural Resources Conservation Service (NRCS) manages the Agricultural Conservation Easement Program (ACEP) with two program components: Agricultural Land Easements (ALE) and Wetland Reserve Easements. There is substantial financial support for ACEP through the Inflation Reduction Act, which will provide \$1.4 billion over five years. Three Valley Conservation Trust continues to partner with the NRCS serving as an agricultural easement co-holder for the ACEP-ALE program. For the October application round 12 new applications were submitted along with four reapplications. The next ACEP-ALE application deadline is December 20, 2024.

As we approach this season of gratitude, we hope you and your family find joy in the things that matter most.


Save These Dates!

What Have Members Been Doing Lately?

Fall Hikes for Acres:

In Appreciation of the Partnership between Metro Parks and 3VCT! Article and photos by Julie Bath-Primack

This fall's Hikes for Acres had a theme: all three parks we visited are now Butler County MetroParks. All three properties belonged to individuals who wanted to preserve these special areas for future generations. Although not the final custodian of these properties, 3VCT partnered with other organizations, including MetroParks, Ohio EPA, U.S. Department of Energy and U.S. Fish and Wildlife to restore these properties and protect them with conservation easements. 3VCT often supervised ecological restoration efforts to make these properties perpetually beautiful, peaceful sanctuaries for the many native species of this area. No property takes the exact same pathway to becoming a MetroPark, but all three are now open to residents and visitors to this area, and to their grandchildren and their grandchildren's grandchildren!

Our first two hikes were led by MetroParks Senior Natural Resource and Conservation Manager, Joe Dumyahn. On August 29, we visited Sycamore Bluffs Area, Four Mile Creek MetroPark, which spans both sides of Four Mile Creek. Recently-opened trails, about 1.3 miles, climb a modest hill on an old road through ridgetop woodlands before dropping to more meandering paths long the creek.

On September 26, we visited the Mill Race Metro-Park, beginning at the Black Covered Bridge and lying along Four Mile Creek. The 75 acres of Mill Race is divided into a pollinator garden, a prairie and some forested strips between and around these two meadows. One highlight of the park is that 120 species of native species were planted in the pollinator garden! The abundance of flowering species maximizes the time something is blooming for pollinator use as well as providing the different host plants fed on by pollinator larvae. Joe Dumyahn helped us recognize the enormity of the work done to restore the area - removing invasive

species, planting native species and remediating areas to support plants that supply food and habitat for twildlife. 3VCT is very grateful to MetroParks, Joe Dumyahn and the rest of the staff for all their hard work!

Our third hike was on October 24 at Salamander Run MetroPark. A previous 3VCT

MetroPark. A previous 3VCT board and staff member, Eric Hollins, was influential in getting this property in the Paddy's Run watershed into a conservation easement and

converted into another fabulous MetroPark. Eric, with his wife Catherine, did a wonderful job of introducing us to some of the native plant species currently supported by this area. Also present was Tom Schneider, Environmental Supervisor for the Ohio EPA and leader in the Paddy's Run Conservation Project. Salamander Run opened to the public in 2023. It boasts, among many other things, several salamander species, including Cave (OH endangered!), Eastern Red-backed, Southern Two-lined, and Streamside Salamanders. Spotted salamanders were introduced and are now thriving, plus we have high hopes that red-spotted newts will make their way there from easement properties nearby.

We hope you'll join us in the spring for three more hikes to explore Three Valley easement properties and other natural areas in the area. Check the 3VCT website for details in the spring. www.3vct.org



They won't stop here though - invasive species management is ongoing, and the east bank boardwalk will be extended to near the new dog park when funding can be secured. Kudos to you all!



Sadly, one in eight Americans is food-deprived. FHFH helps fill the food gap by providing thousands of pounds of wild game each year to food banks and pantries across the country. Since their inception in 1997, the organization has provided over 23 million meals to needy Americans. An average-size deer can supply 160 meals to those in need. Our partnership with FHFH at Fossil Creek not only provides venison for local residents, it also enables the hunters to watch over the wooded area to ensure no illegal poaching of deer is occurring. Thus, it is a win-win for all involved – the hunters, local food outlets, and of course, those in southwest Ohio needing food for their families.

I have had a partnership with FHFH on my own properties for over 20 years and what has impressed me the most is the complete integrity of the farmers and hunters who cooperate with the organization. Everyone I have had contact has been highly honorable and professional, committed to using the wildlife resources of our area to benefit those less fortunate. This is another important mission Three Valley has undertaken to make a difference in southwestern Ohio...and it all starts with land conservation!
