Milkweed Madness! By Donna McCollum

Entomologist Doug Tallamy, in his book <u>Nature's Best Hope</u>, states if we all put just half of our lawns into native habitats, we would have a "homegrown national park" larger than all U.S. national parks together. Would you like to be part of the effort? If so, a good start would be to find a patch of grass you don't want to mow anymore and plant native plants there. It might be a shady patch under a tree where grass doesn't grow well anyway. Or it might be an area that stays damp, so it is hard to mow. Maybe it's a sunny corner you could round out to make mowing easier. Or would you like to move the border of your garden bed out by a foot to plant some showy flowers? Any area, no matter what size, taken out of lawn and put into native plants will help restore habitat for a multitude of organisms who might find a home there.

Some of the best plants for a sunny spot are milkweeds, genus *Asclepias*. Three Valley is working with Riverside nursery to make 6 species of milkweeds available for your gardens, while raising money for the Trust. The six species include butterfly weed and common, prairie, Sullivant's, swamp, and whorled milkweed. A species for every habitat! Find more information about each of them and place an order at www.3VCT.org – 2022 Milkweed Order Info.

For now, though, let's think about why 3VCT has decided one good conservation practice is to plant milkweed plants. You may have seen butterflies at your flowers before, and we all know our bee and wasp pollinators are in real trouble,

but perhaps the biggest value of native plants is the food they provide for leaf-eating insects. The leaves capture radiant energy from the sun and turn it into chemical energy (carbohydrates) that can be used by other organisms. The largest group of herbivores on the planet is insects; they eat about 95% of all vegetation that gets eaten on earth. You might shudder at this, thinking maybe feeding so many insects is not a good plan! But the truth is, these insects make primary producers' (plants') energy available to the rest of the trophic levels. Just think about all the animals that eat insects . . . ants, birds, lizards and so many more! Common milkweed alone feeds over 450 species of insects, including everyone's favorite, monarch butterflies, of course!

Monarchs, like all moths and butterflies and many other insects, go through complete metamorphosis – i.e. egg => larva => pupa => adult. The larval stage is a caterpillar, the favorite food of sooooooo many animals, especially birds. Why would that be? Well, cater-

pillars are larger than most other insects, they are fairly soft, they are often visible as they feed on leaves out in the sunshine, and they are filled with proteins, fats, carotenoids and other nutrients baby birds need. And baby birds eat a LOT of caterpillars. Research shows it takes over 4,000 caterpillars to raise a nest full of downy woodpeckers and 6-9,000 to raise a clutch of Carolina chickadees!

Please consider doing your part for nature. Buy yourself a plant, or buy yourself 20 plants! Buy your neighbor a plant or several. Buy your sister a few for her birthday and your dad a few for father's day (along with a promise to plant them when they come in!). Plants will arrive in early September, just in time for fall planting so the roots can get a good start before the dry season next year. Not only will you be spreading the wealth of native plants, your purchase will support Three Valley's mission.


Howard Creek-Dry Fork Whitewater River Watershed Planning Project By Agnes Marchlewska, Environmental Solutions AQ

Public Meeting Notice

Three Valley Conservation Trust (3VCT), in partnership with Upper Dry Fork Collaborative, will hold a second public meeting May 19, 2022 at 6:00 p.m to discuss developing a watershed management plan (9 Element Nonpoint Source Implementation Strategy) for the Howard Creek – Dry Fork Whitewater River Watershed.

The purpose of the plan is to improve the water quality within this watershed by identifying and evaluating sources of impairment and determining what water quality goals, restoration methods, and conservation practices are needed. In the plan, critical areas will be identified and may include sections of stream where bank erosion is threatening stream quality, potential wetland areas that are too wet to support crop growth but valuable for habitat improvement, excess sedimentation of the creek, invasive species that are overwhelming riparian areas and more.

Local landowners and easement holders are encouraged to participate in the meeting and assist in: identifying critical areas, developing watershed restoration and protection strategies, and later implementing these strategies.

Within this newsletter, we hope you also find some inspirational news. Our staff and board are working diligently each day to explore new land conservation opportunities and provide our community hope for a better tomorrow. By the time you read this, we will have hosted the first official Ohio River Basin H2Ohio project groundbreaking in Southern Ohio. The Hoffmann Wetland and Stream Restoration project will restore the largest forested wetland on Indian Creek and significantly decrease nutrient and sediment runoff in the watershed.

This project also signals a new and exciting shift in the Three Valley easement stewardship model. Looking to the future sustainability of our lands, we are preparing for the inevitable effects of climate change on our stewardship goals. As a result, we are incorporating climate resiliency into our land conservation strategies through our Soil Health program and enhanced water conservation efforts. Our partnership on the Paddys Run Conservation Project with the Ohio EPA and Fernald Trustees has provided the funding to develop two additional watershed studies in southern Butler County; read more about these in the article submitted by our partners at Environmental Solutions AQ (see p. 2) and in Steve Gordon's article on the Henshaw wetland project in Ross Township. The Soil Health program, led by Land Protection and Stewardship managers Caitlin Brown and Maria Fagin, kicked off in March with a motivating presentation by David Brandt, a well-respected Ohio farmer and international speaker on the advantages of regenerative farming to tackle climate change. Caitlin and Maria have educated themselves on relevant issues in regenerative agriculture, establishing a new cadre of partners and setting the stage to promote best management practices to ag producers and landowners. More Soil Health programming opportunities will be on our website soon.

More exciting news, our Little Mudders program is back this year (see p. 7). Board member LaTricia Hillman and staff members Caitlin and Maria are excited to welcome families to explore the unique habitats and species of SW Ohio. Many of our landowners will host these events and showcase their own efforts to restore and protect nature.

We also invite everyone who lives in this watershed to to share your thoughts and help us prioritize conservation efforts by filling out a short survey, which can be accessed at www.hcswcd.org/udf-watershed.html.

The 9 Element Plan developed for the Howard Creek-Dry Fork Whitewater River will be submitted to Ohio EPA for the review at the end June 2022. Once the plan is approved, projects identified within the critical areas will be eligible to apply for grant money to implement restoration and management measures. In July 2022, TVCT will begin developing the 9 Element Plan for the adjacent watershed, Paddys Run Watershed.

The public meeting will be held in Morgan Township Community Building at 6463 Okeana Drewersburg Rd., Okeana, Ohio 45056. No registration is required.

There is so much more happening, especially at Ruder Preserve. This year, we continue eradicating invasive species, planting native species, hosting Eagle Scout projects, and extending our limited mobility boardwalk to make the preserve welcoming to people of all ages, backgrounds, and abilities. Ways to volunteer time or donate funds toward the Ruder projects can be found on our website or by calling the Three Valley office.

As we spring into 2022, I want to welcome our newest board member, Mark Rentschler, and thank our retiring board members, Suellen Albert and Board Chair, Daniel Cox. I also want to thank Amy Sullivan (Secretary) & Ed Teets (Treasurer) for continuing as officers and our two new board officers, Tom Vogel (Chair) and Barbara Hamilton (Vice Chair). The passion of the board and staff for conservation and our mission should provide us all great hope for the future of Three Valley and our conservation community.

To our members, donors, sponsors, and partners - thank you for supporting 3VCT's mission and making our work possible. You are our best hope for ensuring a thriving, climate-ready future. Since our last newsletter, Three Valley has closed two easements, totaling 250.28 acres, bringing us to 217 easements. One was a donated agricultural easement in Butler County and the other an Ohio Department of Agriculture (ODA) funded agricultural easement in Preble County. We submitted ten applications in December to NRCS's Agricultural Conservation Easement Program under the Agricultural Land Easements (ACEP-ALE) component for their 2022 funding round; we hope to hear if any easements were funded in May. We also submitted twelve applications to the ODA's Local Agricultural Easement Purchase Program (LAEPP) in April; awardees should be announced in June. As the ODA local sponsor for Preble and Butler Counties, 3VCTwas allotted \$214,000 for easements in the 2022 round.

The Bittner and Wilson Farm

Karen Bittner and Barbara Wilson donated an agricultural easement on their 140.28-acre family farm in November of 2021. The farm has prime agricultural soils, with 92.81 acres of tillable land. It also has over 7,400 feet of streams running through 37.66 acres of forest that provide ideal habitat for a variety of species.

The Rodeffer Family

Our final easement of 2021 was the Rodeffer family's 110-acre farm, which was funded through ODA's LAEPP program in 2020. The Rodeffers have been part of the 3VCT family since 2007 and have multiple farms protected by the Trust. In January of 2022, the Rodeffers opened a butcher shop in Eaton, called Rodeffer Meats, which offers a variety of local beef, chicken and pork.

The Henshaw Wetland Project – A Brief Update By Stephen Gordon

The Henshaw wetland is an exciting restoration project in Morgan Township that is a haven for seven amphibian species. The project, introduced in the fall 2021 newsletter, had been delayed by the pandemic. Today's good news is the restoration contractor has finished a comprehensive proposal and design for the existing wetland and proposed habitat expansion and 3VCT submitted an application to the Ohio River Basin H2Ohio Program on March 29, 2022. The Ohio Department of Natural Resources expects to notify funding awardees sometime in May 2022. If funded, 3VCT expects to break ground on the project in late 2022 after harvest and complete the project in late 2023.

Ruder Preserve Update By Donna McCollum, Ruder Management Team

Spring has been good at Ruder Preserve. Restoration work has continued, thanks to several groups of students from Miami's Alpha Phi Omega service fraternity and Marine Biology Club. We have worked on removing honey-suckle and garlic mustard, of course. We also are continuing to remove non-native Osage orange trees that were overtaking the entry area. In place of the those we've planted native flowering shrubs, including arrowwood viburnum, spicebush, and elderberry, as well as a seed mix to expand pollinator resources in the resultant sunny areas.

The management team also has met with two boy scouts planning Eagle Scout projects at Ruder Preserve. One scout plans to establish the pollinator gardens we have prepared the way for and the other wants to continue the boardwalk. We look forward to working with both of them!

To see some of our progress in increasing species diversity, check out the research done by an MU undergraduate student, Lauren Vajentic . She finished a report on her fall research that will soon be linked to 3VCT's web site.

Our enthusiasm as a group is growing with each meeting, so I find that very exciting and rewarding. The rest of the books for this year include:


June 9th: Bright Green Future by Gregory Schwartz and Trevor Decker Cohen; leader is Cori Yeager.

If you are looking for an optimistic view of the future, this is a great place to start.




August 11th: How to Talk to a Science Denier by Lee Mcintyre; leader is Ben Mattox.

3VCT staff members Caitlin Brown and Maria Fagin organized a Soil Health Day program on Saturday, March 26th at Chrisholm MetroPark in Trenton, Ohio. Thirty-five people, including representatives from Butler Soil and Water Conservation District, Integrated Ag services, who provide soil sampling and nutrient mapping for farmers, and Duvelius Ag Supply, who supply local cover crops, attended an excellent presentation by "soil health pioneer" Dave Brandt.

Dave, who farms 800 acres in Fairfield County, Ohio,

began no-till practices in 1971. Through trial and error, he succeeded in reinvigorating his soils by using mixed varieties of cover crops, significantly reducing erosion and the need for synthetic fertilizers and chemicals. Dave shares his





years of experience and knowledge in the regenerative agriculture business so that others have an easier road. "I'm trying to pass on what we've learned here. I don't want everyone to reinvent the wheel. I want people to see our failures and our successes." As a leading figure in soil health advocacy in our region, Dave regularly hosts soil health programs at his farm in Carroll, Ohio. • The Membership Team, led by Mark Boardman, recruits and retains 3VCT members. Membership, currently 257 households, continues to increase. Their goal is 300 new members by 2030. The committee has produced the new monthly electronic newsletter, Conservation Connections, which is emailed to 750 people. It provides information about 3VCT events and conservation events sponsored by other organizations in our region. Stay tuned for activities geared to members, including special activities for those who donate at the guardian level.
