6:40 pm Called to order by Chair Mark Boardman, 75 members were in attendance.


Approval of Minutes moved to accept the minutes from the 2017 Annual Meeting held on January 28, 2018. The motion was seconded by and approved unanimously.

Treasurer's Report

Ed Teets

Ed reported that TVCT is in a very good financial situation with 2018 ending with a surplus of \$8,224. Our expenses totaled \$260,065, and income from contracts, endowment earnings, the auction, elegant dinner, and donations provided \$268,289.

Special thanks to Frank House and Ann Geddes for organizing and hosting the Elegant Dinner fundraiser. And special thanks to the children of Wally and Marilyn Edwards for their generous contributions to the Endowments and Land Acquisition Funds.



The 2017 audit was once again a clean one.

Planning for the 2019 Budget is based on expectations of earnings from contracts of \$48,624, and \$107,920 from the Endowment (following the policy of using 4% of the income averaged over three years.)

The Board has also made a goal of raising \$117,655in donations and membership funding. The Budget for


Review of 2018 Land Stewardship

Mark Boardman

Land Preserved with Easements: In 2018 the Trust closed on 5 easements adding 570 acres under protection. This brings the total number of easements to 195 and the total number of acres to 22,653 which accounts for approximately 3.5% of both Preble and Butler Counties. Three of the easements were in connection with the Paddys Run Conservation Project in partnership with Ohio EPA. The legal appeal regarding perpetuity and enforcement of land easements was decided in favor of Three Valley Conservation Trust. The Trust can, and will, enforce

conservation easements. Easements are forever. Protected Acres 10,20

OEPA-TVCT Partnership: In 2018, 343 acres of land were protected on three diverse easements, bringing the total land protected in the project area to 4527 acres on 47 easements.

TVCT-PRCP-MetroParks Partnership: Fossil Creek, a 44 acre property owned by the Trust, has been the focus of invasive plant species eradication contracted to Songbird Environmental. Soon, several vernal pools will be created before the property is transferred to MetroParks of Butler County.

Habitats: In 2018, Davis visited 22 properties where he recorded salamanders, frogs and toads, turtles, lizards and snakes. After 30 years of amphibian field searches, Davis observed rare salamanders in Morgan Township. Davis's findings remind us of the importance of abandoned ponds, vernal pools and ephemeral headwater streams. These often overlooked features provide breeding and hibernation habitats for amphibians and reptiles.

Outreach and Education



Remarks by the Outgoing Chair

Mark Boardman

I have been on the Board for a decade and served as Chair for half of that time (including one stint as defactor interim Director). During that time, I have become increasingly aware of the vital role that Three Valley Conservation Trust is playing for today's world as well as the world of tomorrow.

Land and land use is a type of public commons. Land use is the cornerstone of stream and groundwater quality and quantity, of biologic diversity, of sustained agricultural productivity and is critical to climate control and to our mental and physical health. These aspects of our common life are part of our common wealth, our commons. Land conservation and stewardship <u>today</u> is absolutely necessary for a reasonable quality of life in the near and far future. Wise land use is our Legacy of Conservation.

In 2019, Three Valley celebrated its first 25 years of success sustaining the land stewardship mission given to us by Wally Edwards and other founders, a mission that leaves a Legacy of Conservation. In terms of easements and acreage, in 2019, we surpassed 200 easements and 20,000 areas of land. We are the largest land trust in southwest Ohio (third largest in Ohio).

We are no longer an all-volunteer organization of a few dedicated individuals meeting in homes. Our easements are no longer mostly donated, but rather, are often government subsidized (i.e. more legal issues, forms, etc.). Many properties are being sold; so the new landowner needs to become a new partner for us. Conservation violations and other legal issues are common. Today, we need and have an excellent professional staff, legal and accounting consultants, several governmental partners, and rented offices, insurance, etc. I am proud that we are well on our way to being the full-service professional land trust needed to meet our mission today. I am glad to have been a part of it.

And now I am stepping down as chair to devote more of my time to ensuring the future success of Three Valley's mission and to meet the enormous challenge of strategically preserving land for the benefit of future generations. The Trust is a non-profit organization with an annual budget - but a perpetual responsibility. It all takes money. We have an excellent endowment to go with our excellent staff - for today.

But as we continue our mission of land stewardship via acquisition of new easements and defense of old easements, our support needs will grow; so our annual giving and our endowment must grow. In the next several months, you will be hearing from me and others to make commitments for the future of land stewardship by including Three Valley in your legacy plans as well as your annual giving.



Finances


Ed Teets, Treasurer

Budget Overview:


- Expenses for 2019 were \$ 13,264 higher than expected (≈ 5%). This increase is partly a result of increased legal fees associated with easement protection. Policies have been reinforced to forfend similar future legal costs.
- Income for 2019 was substantially lower than expected. Donations were lower by \$33,007. This decrease in donations has several possible causes, and the new Executive Director (Randy Evans) and new board are tasked with addressing the critical need for sustained donations.
 Contract income was lower resulting from the phasing out of the Paddys Run Conservation Project.
- Endowment growth in the 2019 calendar year was substantially higher than in previous years. Partly this growth results from a strong market (20% growth in calendar year 2019) that included a the rebound from a ≈ 10% drop at the end of 2018 (i.e. skewing our calendar year calculations). The 2019 budget imbalance was met by using income from our endowment. The careful stewardship and cautious use of endowment income is clearly important for sustaining the mission of Three Valley. The need for a strong endowment is critical to Three Valley's success.

 In December, 2019, the portfolio was adjusted to reduce the risk allocation of funds. Approximately 10% of the endowment is now held as U.S.
 Government Money Market Funds. This decision likely softened the effect of the recent decrease in the stock market.

 On Earth Day, April 22, 2020, our stock portfolio is valued ≈ \$ 3 million (≈ 10% loss from maximum value; green star on graph above).

Easement Acquisition and Stewardship

Randy Evans, Executive Director

Easement Acquisition: In its 25th year of operation, the Trust passed a milestone of 200 easements. The addition of the 6 easements secured in 2019, the Trust now protects over 23,000 acres and 202 easements.

Charles Chip Hafele 159-acre OEPA-Paddys Run Conservation Project Butler County




Easement # 197 closed in January 2019. Charles Chip Hafele had a vision of creating a mosaic of habitat from oak woodlands to vernal pools on his 159 acres. In spring 2019, Chip retired many row crop acres from production and worked with Butler County Pheasants Forever member Al Gerhart to install tallgrass prairie habitat on the retired acres. The unique location of Chip's property helps extend native habitat provided by Governor Bebb Metropark, which borders the easement on the east and south boundaries. The Paddys Run Conservation Project provided funding for the property.





197: The Hafele easement (Butler County) closed in January 2019. Charles Chip Hafele had a vision of creating a mosaic of habitat from oak woodlands to vernal pools on his 159 acres. In spring 2019, Chip retired many row crop acres from production and worked with Butler County Pheasants Forever member Al Gerhart to install tallgrass prairie habitat on the retired acres. The unique location of Chip's property helps extend native habitat provided by Governor Bebb Metropark, which borders the easement on the east and south boundaries. The Paddys Run Conservation Project provided funding for the property.







198: The Bullock easement (Preble County) closed in April 2019. Robert and Marilyn Bullock have what many consider a picturesque example of prime SW Ohio farmland. They have 93-acres of pristine row crop acres and their beautiful homestead could certainly grace the cover of a magazine. Ohio Department of Agriculture funding helped protect these vital acres of production farmland.



199: The Thomas easement (Butler County) closed in August 2019. Beverly Thomas has been a longtime supporter and advocate of TVCT as well as the Miami Valley Audubon Society. Her 22-acre property hosts a beautiful lake, pine forest planted in 1954 by the Ohio Division of Forestry, and an area of remnant Ohio prairie. Four Mile Creek borders the property on the west, and Sycamore Bluffs Metropark borders the east side. Beverly Thomas donated the conservation easement to Three Valley.



200: This Kilroy easement (34 acres in Montgomery County) closed in August 2019. Mike and Vickie donated both conservation easements to Three Valley. Mike and Vickie are lifelong conservationists and are dedicated to protecting the natural and cultural history of their properties. The 34-acre property south of Hemple Road serves as a tree farm and is actively managed as a nature preserve. Vickie is an avid animal advocate who has spent many years raising abandoned and injured wildlife. Mike and Vickie Kilroy donated this easements to Three Valley Conservation Trust.



201 The 2nd Kilroy easement

(Montgomery County) is an 82-acre property north of Hemple Road that includes a productive farm hosting woodland habitat, a historic family farm cemetery maintained by the Kilroys, and a restored bank barn and farmhouse - both built in the 1840's. Mike and Vickie Kilroy donated this second conservation easement to Three Valley Conservation Trust.





202: The Pence easement (Preble County) closed in October 2019. John Pence and family began working with TVCT staff in 2015. John Pence, a lifelong area farmer and Washington Township trustee wanted to protect the 82-acre family farm from nearby development pressure. The entire acreage remains in row crop production and the family reserved a 5-acre homestead. Ohio Department of Agriculture funding helped protect these vital acres of production farmland.

Prospects for Easement Closings in 2020: The Three Valley staff and board remain committed to helping landowners protect their property from subdivision and development. In 2020, we expect to close between up to 10 easements. We expect between 5 and 7 agricultural easements to be closed that are funded, in part, by ODA (Ohio Department of Agriculture), and we are working on 3 conservation easements that will be donated. We are also working with additional landowners in Montgomery County who wish to donate conservation easements.

Property Management and Contracts

Tom Vogel

Helen Angst Preserve: In October, 2019, 82 acres of property west of Trenton was bequeathed to Three Valley Conservation Trust by Helen Angst.

In the fall of 2016, Helen Angst expressed her desire to have her property become a public preserve operated by MetroParks of Butler County with a conservation easement held by Three Valley to ensure conservation in perpetuity. The Angst family participated in this decision and supported her wishes from the beginning. Last year, Helen died at the age of 93.


Three Valley will maintain ownership of the property while MetroParks of Butler County develop plans and secure funding for the creation of a public-access preserve and for purchasing the property from Three Valley. Of course, there are other details, but the goal is for

- MetroParks to own the land and manage the preserve,
- Three Valley to ensure the conservation value of the land, and
- the public to have a wildlife preserve.

We thank Helen Angst and her family for this wonderful gift to the community, and we thank MetroParks of Butler County for another significant partnership venture. In this way, Helen Angst and her family created a *legacy of conservation*.

MetroParks is pursuing funding from the Clean Ohio program to buy the property from Three Valley and create trails and public facilities. A recent rendition of plans prepared by MetroParks is shown below. Acquiring this funding is currently delayed because of the Coronavirus pandemic.

We look forward to the success of this project. The back-up plan is to place a conservation easement on the property and sell it. Approximately 50 acres of the property is currently being farmed.



Ruder Preserve: was the first property entrusted by three daughters in honor of their mother, Helen S. Ruder.. It was donated to the Trust in the 1996 The 14 acres constituting the Ruder Preserve straddle Four Mile Creek east of the bridge linking Bonham and Talawanda Roads.



In 2019 the first phase of the ADA-compatible boardwalk was completed thanks to the extraordinary efforts of many, many volunteers. Special thanks to Donna McCollum for organizing hundreds of Miami student contributors, a grant she wrote, and hours of restoration/construction work.









The construction / restoration included many TVCT members. A few are named, but many, many more contributed: Mark Boardman, Hays Cummins, Trish Clemmons, Barb Hamilton, and on and on.

Thanks to a special donation by Nancy Nicholson, a concrete parking area was poured by Anzano and Powers to provide reserved handicap-accessible parking.







An opening ceremony occurred in early October with several speakers. Besides Mark Boardman and Donna McCollum, speakers included Ann Whelpton (Oxford Village Network) Dan Darkow (Miami University Disabilities Needs, and Kathy McMahon-Klosterman (disabilities advocate).

Funding for the boardwalk construction has been provided entirely by grants and donations, notably by Nancy Nicholson, Linda and Mark Boardman, and a Miami University service fraternity.

An extension of the boardwalk (phase 2 of 3) that leads to another resting area overlooking Four-Mile Creek is nearing completion. This phase was funded by the Wakeman Foundation (Hardy and Barb Eshbaugh).

A new split-rail fence was installed by the Ruder Management Team (Donna McCollum, Mark Boardman, Randy Evans. Steve Gordon and Barb Hamilton)

Because of the honeysuckle removal, the riparian forest can be seen, and native plants like paw paw, white snakeroot and sycamore are making a comeback.. Because of the ADA-accessible boardwalk and parking, Ruder Preserve is visited by many persons of all mobility levels for a peaceful walk, nature-watching, educational purposes. It is becoming a showcase for Three Valley stewardship.
