THE TRUST ALSO MONITORS THESE EASEMENTS (LAND STEWARDSHIP). IN 2021, TVCT FACILITATED THE APPROVAL AND FUNDING OF 7 NEW EASEMENTS. TVCT HOLDS 218 EASEMENTS AS OF THE END OF 2022 WHICH PROTECT 24,500 ACRES OF LAND IN 6 OHIO OHIO COUNTIES AND 1 INDIANA COUNTY.
